About the Award

The Association of Early Childhood Educators of Newfoundland and Labrador (AECENL) is proud to present the *Early Childhood Educator of the Year Award*. This award celebrates an exceptional individual who exemplifies the highest standards of excellence in early childhood education.

This prestigious honour recognizes an Early Childhood Educator (ECE) who demonstrates unwavering dedication to nurturing the holistic development of young children, while fostering inclusive, engaging, and supportive learning environments. The award also highlights those who champion high-quality early learning and act as visionary leaders, innovative practitioners, and trusted partners to families and communities – ECEs who inspire, advocate, and elevate the field through both their daily work and long-term impact.

Award Eligibility

This award is open to Early Childhood Educators who:

- Are a resident of Newfoundland and Labrador.
- Hold a Level I, II, III, or IV provincial Child Care Services Certification
- Are currently employed in a regulated child care service in Newfoundland and Labrador.
- Have a minimum of two years of continuous experience in the field.

Please note: Recipients of this award are not eligible for re-nomination until five years have passed since their last recognition.

What do recipients receive?

Recipients of the award receive the following:

- An award from AECENL
- Free 1-year AECENL membership
- \$50 gift card
- Provincial recognition at AECENL's Annual Provincial Early Learning and Child Care Conference, as well as on AECENL's social media platforms, in honour of recipient's contribution to excellence in early childhood education and their commitment to building the strong foundation children need for the best possible start in life.

AECENL's ECE of the Year Award Nomination Application Package

The application package for AECENL's Early Childhood Educator of the Year Award consists of two parts:

Part A: AECENL's ECE of the Year Award Nomination Form—completed by the nominator on behalf of the person being considered for the award—can be found at the end of this document.

Part B: Nominator Award Criteria Response – completed by the nominator - information on how to complete this section can also be found at the end of the document.

How to Prepare the Nomination Application Package

Nominators may be any person or group with direct knowledge of the nominee's contribution (ECE, co-worker, parent, Administrator, Licensee etc.). The following nomination methods are strictly prohibited: self-nominations and nominations submitted by immediate family members.

Once you determine the nominee meets the eligibility criteria, you can prepare the nomination package. A complete nomination package consists of two requirements:

- AECENL's ECE of the Year Award Nomination Form
- Nominator response document that outlines how the Nominee meets the 7 award criteria areas.

You can nominate up to three individual Early Childhood Educators, each ECE will require a separate nomination application package.

Failure to provide any one of these requirements may result in your nomination to not being evaluated.

Deadlines, Adjudication, and Presentation of Award

- The deadline for applications is 12:00pm on September 22, 2025. Completed Application Packages are to be submitted to AECENL.
- Applications will be adjudicated by the AECENL Board's ECE of the Year Award Review Committee. To ensure fairness, each application package will be assigned a number, and the review committee will not have access to any identifying information such as name, workplace, address, etc.
- The recipient will be announced at the 33rd Annual AECENL Conference that is taking place on October 4th, 2025, at the Holiday Inn, in St. John's. Recognition will also be given via social media such as Facebook and Instagram.

Submitting The Completed Nomination Application Package:

Before submitting your nomination, please ensure to:

- Print the nomination form
- Complete all required sections of the nomination form ensuring that both the nominee and nominator sign and date the form
- Ensure you have included all required attachments (Part A and Part B) which is the Nominator Award Criteria Response document.

After submitting your nomination, you will receive a confirmation email acknowledging receipt. Please note that AECENL cannot consider incomplete applications. It is your responsibility to ensure that your application is complete. If any document is rejected, you will receive an email explaining the reason. You should submit the corrected document as soon as possible. To avoid missing important communication, please add AECENL to your email contact list as a safe sender.

PART B: Nominator Award Criteria Response Guidelines

Nominators are expected to provide thoughtful and detailed responses explaining how the nominee meets each of the award criteria listed below. The selection committee relies solely on these responses in selecting the recipient. The nomination package should clearly illustrate the nominee's outstanding achievements and express why the individual deserves one of the province's highest honours for ECEs. Each response should:

- Be approximately 100–200 words per award criteria question (7 responses total, see list below).
- Include specific examples from the nominee's professional experience.
- Clearly demonstrate alignment with best practices in early childhood education.
- Highlight instances of innovation, leadership, and advocacy, where applicable.

Award Criteria List

Demonstrated Excellence in Teaching

Provide examples of how the nominee uses developmentally appropriate practices, creates a nurturing, inclusive, and engaging learning environment, and promotes social-emotional, cognitive, and physical development.

Commitment to Professional Growth

Describe how the nominee pursues ongoing education and training, and shares knowledge with peers through mentoring and/or professional development.

Positive Impact on Children and Families

Provide examples of how the nominee builds strong relationships with children and their families and encourages family involvement in the learning process.

Leadership and Advocacy

Describe how the nominee advocates for high-quality early childhood education and demonstrates leadership within their program and community.

Innovation and Creativity

Provide examples of how the nominee implements creative teaching strategies and curriculum enhancements and adapts to the needs of diverse learners.

Community Engagement

Describe how the nominee collaborates with community organizations or participates in outreach and promotes awareness of current trends in early childhood education.

Additional Considerations

Include any additional information such as length of service in early childhood education, if they are an AECENL member, contributions to quality improvement initiatives, and testimonials or letters of support from colleagues, parents, or students.
